Members of the Licensing Panel of the Council's Regulatory Committee considered the above application, full details of which appeared before the Members in their agenda and the background papers.

Prior to making their decision the Members heard from Mr Bradbury, the applicant. Members also considered a written representation from Mrs Howard, a neighbouring resident, who could not be present at the meeting.

Having carefully considered those matters brought before them, the Committee were of the opinion that the application should be **granted subject** to the conditions appearing below. In reaching their decision, the Members had full regard to both the provisions of the Licensing Act 2003 and the Council's Licensing Policy. They also considered the relevant case law as set out in Thwaites PLC v Wirral Borough Magistrates Court and R(Bristol Council) v Bristol Magistrates Court. The Members imposed conditions in order to promote the four licensing objectives, namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

The application was granted in respect of the hours of operation of the licensable activities described in the box above together with the following conditions

- The mandatory conditions of The Licensing Act 2003.
- All staff must have undertaken and successfully passed the company's licensing examination within a 12 month period.

**PREVENTION OF PUBLIC NUISANCE**

- Liaison must take place with the police and the local community on a regular basis.

**PROTECTION OF CHILDREN FROM HARM**

- The premises will operate a 'Challenge 25' policy.

**PREVENTION OF CRIME AND DISORDER**

- At all times that the premises are open for the sale of alcohol, CCTV must be in operation. The CCTV system must meet the expectations of the Licensing Authority and the Police.

**PUBLIC SAFETY**

- Any person who appears to be under the influence of alcohol who enters the premises will be banned from them forthwith.

**APPEAL INFORMATION**

Under Schedule 5 Section 2, the applicant or any party making representation may appeal against the decision. Section 9 states that such an appeal must be made to the Magistrates Court within a period of 21 days from the date that the applicant is notified in writing of the decision.
