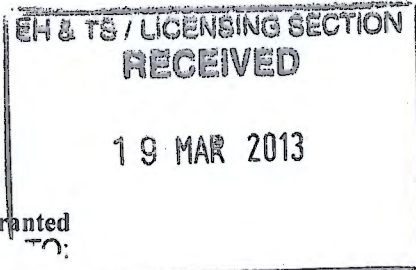

**b) The prevention of crime and disorder**

CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions particularly facial recognition.  
Cameras shall encompass all ingress and egress to the premises.  
Equipment must be maintained in good working order, be correctly time and date stamped. Recordings must be kept in date order, numbered sequentially and kept for a period of 31 days and handed to the police on demand (provided that the police will allow reasonable time for the recording to be obtained in the event that the request for recordings is made at a time when the premises are closed)  
The Premises Licence Holder must ensure that at all times a member of staff is capable and competent at downloading CCTV footage in a recordable format either on disc or VHS to the Police/ Local Authority on demand.  
The recording equipment and tapes/ discs shall be kept in a secure environment under the control of a responsible individual. In the event of technical failure of the CCTV equipment a responsible individual must report the failure to the Police on contact number 0300 333 3000.

Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exits to the premises requesting the public to respect the needs of local residents and to leave the premises and the area quietly.  
Adequate refuse containers shall be located in the premises. Prominent, clear and legible signage (in not less than 32 font bold) shall be displayed at all exits to the premises requesting the public to respect the area and ensure that litter is disposed of properly and in appropriate litter bins.  
The Premises Licence holder will ensure that the area immediately outside the premises is regularly checked for litter during operating hours and that any litter found is disposed of appropriately.
