6. Key Points Summary

- In accordance with the Council's Constitution this report informs this Committee of the Executive response to the Task & Finish Review Community Infrastructure Levy and the Executive Action Plan that has been put in place.
- Overview and Scrutiny Committee commissioned a Task and Finish Group to undertake a review of the Community Infrastructure Levy (CIL). The initial findings of the Group were presented to General Overview and Scrutiny Committee on 10 December 2012

- The findings from the review were accepted by the Committee and the Task & Finish report
 was subsequently forwarded to the Executive for consideration.
- The Cabinet Member Environment, Housing & Planning considered the review and agreed the response on 17 January 2013. A copy of the decision notice, the report the decision was based on and the appended Executive Action Plan have been appended to this report for the Committee's information.
- Due to the timeframe within which the Task & Finish Group had to undertake the review the Group were not able to access a number of key areas of evidence. These are referred to in the Executive Action Plan.
- The Chairman of the Task & Finish Group, Councillor EP Harvey, is aware that the CIL is part
 of the Local Development Framework and that the outstanding issues need to be progressed.
 The Chairman therefore reconvened the Group on 6 February 2013 to continue with the
 review.
- A report into the findings of this subsequent review will be reported to this Committee in due course.
