On Monday 17 th December 2018, I was working at Hereford Police Station in full uniform leading a Multi Agency Targeted Enforcement Strategy (MATES) Meeting.		
A briefing took place at Hereford Police Station shortly after 17:00hrs and involved Officers from West Mercia Police and Home Office Immigration Enforcement.		
At approximately 17:59 hrs I entered The Taste of Raj Indian Restaurant located at 67 St Owen Street, Hereford in company with PCSO 40023 Kirsty Jenkins and Immigration Officers 4956 Aeltaf KAHN and Mirza AHMED. Mr Gavin KEMP from Herefordshire Council Environmental Health was also present.		
We entered the premises under powers provided by Section 179 Licensing Act 2003. The restaurant was open to the public at the time but no customers were inside.		
I was the first Officer through the front door as I knew the layout of the premises having located persons working illegally on previous enforcement visits.		
I noted one male in the restaurant who was standing near the bar area as Ataur RAHMAN who is the Front of House Restaurant Manager.		
I made straight for the kitchen at the rear of the room where there is a wooden door with a glass window at head height. As I made my way towards the door I saw three males in the kitchen all at work stations. One male clocked me coming towards the door and he immediately turned around and started to hurry towards the rear fire exit door out of the kitchen into the street. One of the other males appeared to hold their arm out to stop him which he then did.		
I then opened the kitchen door and asked all three males to stop cooking and remain where they were until checks were made by Immigration Officers.		
I took a photograph of the two older males		
The youngest male in the room who in my opinion had attempted to run from the kitchen appeared nervous and agitated.		
I recognised the older two males from a previous visit to the premises who had no Immigration issues on previous checks.
