#### **Incidents:**

1. Date: 30/12/2018 21:00

**Description: ASSAULT** 

A CUSTOMER ENTERED THE PREMISES INTOXICATED WHO IS KNOWN TO BE AN ALCOHOLIC CALLED XX. THE MALE EMPTIED HIS WALLET ONTO THE BAR AND WAS THEN ASKED TO LEAVE THE BAR. HE WAS THEN EJECTED FROM THE PUB BY THE DPS ' PARTNER.

WHEN EJECTING THE MALE KICKED THE IP IN THE GROIN AREA AND WAS FORCEFULLY REMOVED IN A BEAR HUG AND TAKEN OUTSIDE. THE IP WAS ASSISTED BY HIS COUSIN WHO HELD THE SUSPECT MALE AGAINST THE WALL OUTSIDE. THE SUSPECT THEN THREW A PUNCH AT THE IP MAKING CONTACT. THE 2ND MALE WHO WAS ASSISTING PUSHED THE SUSPECT BACK WITH 2 OPEN HANDS UPON WHICH THE SUSPECT FELL BACKWARDS ONTO THE FLOOR BANGING HIS HEAD AND CAUSE AN INJURY WHERE IT BLED. THE SUSPECT WAS TAKEN TO HEREFORD A+E.

WHEN OFFICERS ATTENDED LATER THAT SAME EVENING AT 2248HRS TO DOWNLOAD THE CCTV TO A WEST MERCIA USB STICK (PUMA).

THE DPS HAD CLEARLY BEEN DRINKING BUT WAS NOT DRUNK. HER PARTNER THE ORIGINAL IP WAS VERY INTOXICATED AND DRUNK.

IT WAS EXPLAINED TO THE DPS THAT THE CCTV FOOTAGE WAS REQUIRED BY THE OFFICERS AND IT WAS TO BE DOWNLOADED TO THE USB STICK THEY WERE PROVIDING.

THE DPS AND HER PARTNER WERE NOT ABLE TO DOWNLOAD THE FOOTAGE AS THEY DID NOT KNOW HOW TO DO IT. THEY HAD A HAND-WRITTEN GUIDE COMPLETED BY A FRIEND BUT WERE STILL NOT ABLE TO DOWNLOAD THE FOOTAGE FOR THE OFFICERS. IT WAS POINTED OUT THAT THEIR LICENCE STATED 'THE PREMISES LICENCE HOLDER MUST ENSURE AT ALL TIMES A DPS OR APPOINTED MEMBER OF STAFF IS CAPABLE AND COMPETENT AT DOWNLOADING CCTV FOOTAGE IN A RECORDABLE FORMAT EITHER DISC OR VHS TO THE POLICE/LOCAL AUTHORITY ON DEMAND' —

THEY WERE NOT ABLE TO DO THIS. OFFICERS WERE AT THE LOCATION FOR AROUND AN HOUR WHILE THEY ATTEMPTED WITHOUT SUCCESS TO DOWNLOAD IT.

#### **Description: COMMON ASSAULT - ASSAULT ON DPS**

THE SUSPECT AND THE IP HAVE BEEN IN A RELATIONSHIP FOR AROUND 3 YEARS AND HAVE RECENTLY TAKEN OVER OWNERSHIP OF THE DUCKER BAR (DUCKING STOOL). THIS EVENING, THE IP HAS BEEN RUNNING THE BAR WHILE THE SUSPECT HAS BEEN DRINKING SINCE AROUND 3PM. WITNESSES HAVE BEEN THERE FOR THE MOST OF THE DAY.

THE SUSPECT HAS BECOME MORE AND MORE DRUNK AS THE DAY HAS GONE ON. A CONFRONTATION HAS BROKEN OUT BETWEEN THE IP AND THE SUSPECT AND HE HAS BEEN STOOD IN HER FACE SHOUTING AND SWEARING.

HE HAS THEN PUSHED THE IP BACKWARDS ONTO THE POOL TABLE, AND LATER PUSHED HER AGAINST A WALL. HE HAS TAKEN HIMSELF TO BED AND THEN WAS ARRESTED FOR ASSAULT. THE VICTIM HAS DECLINED TO MAKE A COMPLAINT AND DUE TO THIS SHE HAS REFUSED THE POLICE ACCESS TO THE CCTV.

**Description: ASSAULT ON STAFF - DPS** 

SIAN ROOKE-JENKINS IS THE LICENSEE OF A BAR IN LEOMINSTER CALLED 'THE DUCKER'. SHE RESIDES ABOVE THE LOCATION WITH HER PARTNER XX.

DURING THE EVENING OF FRIDAY 8 JUNE 2018 SIAN AND XX HAS ISSUES WITH A CUSTOMER CALLED XX. XX WAS APPARENTLY CAUSING ISSUES FOR A FEMALE BAR STAFF AND SO WAS ASKED TO LEAVE BY THE OWNERS PARTNER.

XX REACTED ANGRILY AND GRABBED THE OWNERS PARTNER AROUND THE THROAT, PUSHING XX HEAD IN TO THE BAR. XX MANAGED TO PUSH XX AWAY, BEFORE XX PUSHED XX ON THE FLOOR AND HIT HIS HEAD AGAINST A WALL. SIAN GRABBED HOLD OF XX TO PULL HIM AWAY FROM XX, BUT XX MANAGED TO TWIST SIAN'S ARM, CAUSING BRUISING. OTHER CUSTOMERS THEN MANAGED TO PULL XX AWAY FROM XX AT WHICH POINT XX LEFT THE PREMISES.

SIAN DID NOT REPORT THE MATTER TO POLICE AT THE TIME AS SHE CONSIDERED BANNING XX TO BE SUFFICIENT.

THE MATTER WAS APPARENTLY CAUGHT ON THE BAR CCTV, BUT THIS IS ONLY HELD FOR 7 DAYS BEFORE BEING RECORDED OVER.

THE CCTV FOOTAGE HAS BEEN RECORDED OVER AND IS CONSEQUENTLY NO LONGER AVAILABLE.
