### 1. Summit purpose and aims

The first of an ongoing series of parish council summit meetings designed to share collective knowledge and experience and identify practical ways in which together Herefordshire Council and parish and town councils can promote both prosperity and wellbeing, work together to achieve more and strive to provide the best for our citizens.

72 parish council representatives attended (covering 50 parish councils), plus Herefordshire Council cabinet members, management board and officers. A limited number of partners were present as part of the market place, with some staying on for the summit.

### 2. Feedback on the event

Out of 31 completed feedback forms:

- 28 people found the event either useful or very useful and 27 said their expectations were met.
- Most generally found talks informative and with a significant number (14) stating that they will report back / share learning with parish council and consider further action.
- Many were previously unaware of information available through the council's Intelligence Unit and website and intend to make better use of data sources to research local information.
- The most useful part of the event was the discussion / workshop opportunity (11), the question and answer session (7), the stalls at start of the event (3) plus sharing information, new contacts and possible solutions.

- Some found the talks/agenda too long, many found video sound quality poor and screens hard to read but venue otherwise good. There were also some comments about the limited refreshments on offer, given the time and length of the summit.

### **3. Summary of presentations**

- The Leader outlined the purpose of the summit which was to:
  - provide an opportunity to better understand the challenges within local communities;
  - share opportunities and good practice which already exist;
  - Improve joint working between parish councils and Herefordshire Council, leading to better communication and co-operation to deliver the best for local communities.
- Information from the council's Intelligence Unit raised awareness of population growth, levels of dementia, frailty, falls, loneliness and fuel poverty, with headline data, drilling down to a more local level where available.
- Karen Wright Director of Public Health provided examples of existing good practice to build resilient communities, utilising the assets within those communities.
- Presentations by Weobley Parish Council and Leominster Town Council highlighted their approach to improving the lives of their residents.

### **4. Workshop summary**

#### **a) Social challenges identified:**

- Changing demographics, including an increasingly ageing population and a reduction in numbers of young people.
- Significant challenges due to lack of /reduction in local services, including statutory, e.g. health services and police. Lack of transport cited many times.
- A number of issues related to planning and housing policy, in particular the lack of affordable housing.
- Lack of community, with issues identified such as newer residents not getting involved.
- A shared concern that many of the challenges identified above had an impact on village viability and sustainability.
- Several responses reflected on whether the parish council had sufficient understanding of the needs within its community.

#### **b) Sharing good practice:**

- Many local clubs and activities were identified, some aimed specifically at older people or young families. Some activities also fundraise for local projects.
- Assets were recognised as essential for activities to take place, both the people in the community, their skills, energy and enthusiasm, as well as buildings such as the pub, shop, church or village hall.
- Services were valued, protected and community projects developed locally to maintain them.

**c) Working together:**

- Recognition of the need to all work better together, work differently and in collaboration. Combine all knowledge, experience, best practice and resources to best effect.
- Improve local co-ordination, commitment and leadership and provide more information on practical examples of what can be done to support people in local communities, to aid joint working.
- The need to emphasise a pro-active, can-do approach by both Herefordshire Council and parish and town councils.

**5. Commitment to follow up actions by attendees**

- Almost half of those who completed the feedback forms said that they would report back to / share the learning with their parish council and various local groups and consider points for further action. (14)
- A number also made a commitment to build a more informed picture of their local community, to include exploring data sources on council website and contacting the council's Intelligence Unit for more information.

**6. Identification of specific projects / actions**

These included:

- Development of joint working and networking across parish councils.
- Initiate positive discussions within the parish council and wider community on understanding the needs of the local community, with greater emphasis on community involvement.
- Work with Herefordshire Council to help identify what parish councils can do, emphasis on the positives, not putting barriers in the way.
- Support vulnerable within the community – such as community conference on supporting vulnerable elderly / setting up a good neighbour scheme.

**7. Next steps**

**a) Support better joint working through:**

- Commitment to 24th January 2019 summit with a programme of further summits during the year.
- Liaise with partners i.e. Balfour Beatty Living Places, to ensure that their events and parish council summits are effectively co-ordinated during the year and give adequate opportunity to cover all subjects of working in partnership.
- Send out links to further information on items shared at the Summit plus a copy of this report, with appendices from the evening, to all participants, all parish councils and ward members.

**b) Develop and maintain an ongoing, two-way conversation:**

- Develop communications and sharing of information between events to keep momentum going, to include what parishes and Herefordshire Council have done since the summit.

**c) Areas of focus for future engagement:**

- Share information on schemes / issues which might be of interest to parish councils and between summits, develop a programme of support, such as themed workshops.
- Improved working together to include where appropriate, ward level focus and support a collective approach amongst neighbouring parish councils, myth busting and remove barriers.

### **Responses to Question 1.**

**What are the social challenges in your community and how do they get identified?**

#### **People**

##### **Demographics**

- Do we really know who is in our parish? (2) Isolation - how do we know
- Ageing population (Older demographic (3)) but understanding the community
- No young people left (3) inc (Orcop). Younger people time constraints
- Isolation (5), transport, lack of employment (Brilley), (2)
- Remoteness

##### **Sense of community**

- Transient community, rentals
- Ending up living with family
- Divided Communities (Do not talk with each other)
- Peoples' lives do not centre on village
- Friendship Club - linking residents
- Good Neighbour Scheme - unofficial

##### **Availability of volunteers**

- Age increased before entitled to pension has an impact on volunteering
- Retaining volunteers
- Only a small number of people who do or can get involved
- Need greater recognition of retired people who can do stuff

##### **Role of parish council**

- Relevance of parish council, young do not see it!
- No idea, the PC never discusses these issues!!

##### **Attitudes**

- Lack of response/professionalism/obstructive
- Lack of enthusiasm to do anything
- Cannot see the "social" problem – busy lives
- Country people sometimes do not like to share problems
- Self-reliance but so reluctant to ask for help/getting people to ask for help earlier
- Newer residents not getting involved

##### **Bureaucracy**

- Greater clarity - Do the right thing, rather than hide behind process
- Red tape blocking progress
- Lack of trust to provide information
- Shifting Social Fabric - Myth busting, Negative mind set

##### **Health**

- Health and wellbeing - getting worse because lack of resources
- Lack of co-ordination (social care)

##### **Economics**

- Self-employed people with uncertain income

##### **Place**

- Villages becoming dormitories (2)
- Getting information - who or what is out there, Accessible Data (2)
- Off radar

- ASB (3)
  - Resolve Vandalism and Anti-Social behaviour (Peterchurch)
  - Vandalism, ASB, (Withington)
  - Speeding
- Sustainability / viability of village
- Sustainable assets now but will they be in the future?
- How to do things for children if only a few in a village
- Churches take role in community to identify people who need help
- Preventing people on edge of care getting dependent on care

#### **Reduction/lack of services**

- Loss of services for particular groups, eg reducing bus services and closing pubs
- Meals on wheels gone
- Postman / Milkman
- Local police
- National Health dental treatment / diet
- Support for older population
- Lack of statutory support - police, parking, Highways
- Lack of, or limited access to shops / shopping
- Lack of Facilities, no hub (Brockhampton and Much Fawley)
- Connectivity between IT systems (Firewalls/IG)
- Lack of meeting places (village hall does NOT meet need)
- Don't know social care exists
- Facilities limited – church or village hall only
- Loss of post office
- Amenities

#### **Village sustainability / transport / housing**

- Planning law as it stands skews development away from social provision, eg the CIL 10 + homes
- Housing / property
  - Retirees pricing locals out of housing leading to lack of support network as they age, Issues of people have property but living alone (2)
  - Not enough affordable/social housing (3) or lack of suitable housing for downsizers/FTB
  - Poor housing/overcrowding
  - Homelessness increasing
  - Empty property stock e.g. above shops rectify through pump priming loan/ increase empty rate charge
- Public transport
  - evenings
  - lack of public transport (3), issues with bus links to Hereford (Withington),
  - pick up losses vis dial a ride/uber, (1 bus a week)
- Appropriate infrastructure not attached to developments...S106 not consulted upon
- Local council knowledge link not there, missing opportunity to feedback during timeframe
