The Order shall come into effect on the 22 nd June and is planned to be in effect for 1 week, with each road being closed for the planned duration show in Article 1, attached in schedule 1.			
Reasons for decision:	To enable Balfour Beatty to carry out resurfacing works within the highway, for which purpose the Council, as highway authority, consider the closure of the road is required due to the likelihood of danger to highway users while the said works are being carried out.
