Introduction to the MWLP

- Part of the development plan
 - Sits beneath Core Strategy
 - Minerals can only be worked where they are found
 - Waste should be integrated as a key element of infrastructure
- Policy framework
 - How much development should be provided
 - Where sites should be located
 - Key requirements for development
- Content
 - Introduction and Herefordshire context
 - Vision, Objectives and Spatial Strategy
 - Strategic Policy and General Principles, including development management
 - Minerals: strategy and site locations
 - Waste: strategy and site locations
 - Delivery, Implementation and Monitoring

 - other policy
 - need assessments
 - consultation
- Call for sites and Issues and Options Report, July 2017
- Refreshed evidence base and Draft Plan, January to March 2019
- Refreshed evidence base; updates on phosphates, fracking and sites
- Publication Draft Plan
- Consultation ... planned for early 2021
- Examination
- Adoption

Core Strategy, Sites and EA

- Core Strategy
 - Respondents considered inappropriate lead policy
 - Evidence base of Core Strategy has been reviewed, remains relevant to MWLP
 - Bespoke updated evidence base for MWLP
 - Plan making teams remain in dialogue
- Sites
 - Historic England sought greater specificity and other site comments received
 - Supplementary site assessment work has been undertaken
 - Site allocations reviewed and updated to amend any errors, reflect additional data gathered and make more accessible
- Environment Agency
 - Statutory consultee made wide ranging comments
 - All have been considered carefully and in discussion with relevant officers within Herefordshire Council, some changes have been made



Unconventional hydrocarbons

- Identified as key issue at Issues and Options
 - Cabinet resolution of 16 December 2016
- Petroleum Exploration and Development Licence (PEDL) SO51a
 - Coalbed methane located in south of the county
 - OGA confirmed PEDL not taken up and not awarded (March 2018)
- National Planning Policy Framework
 - 2012 neutral
 - 2018 promoted unconventional hydrocarbons
 - May 2019 promotion text removed by MWS
- MWLP policy
 - Draft Plan draft policy M7 directed development of unconventional hydrocarbons
 - Publication Draft Plan draft policy M1 restricts development of unconventional hydrocarbons



Phosphates in River Wye SAC and Agricultural Waste

- Phosphates in River Wye SAC
 - Known to be exceeding conservation objectives set by NE
 - Recognised to be from two key sources: agriculture & sewage systems (housing)
 - Minerals and waste development not focus for source of phosphates, but can impact
 - Herefordshire Council part of a partnership looking to resolve the matter
 - NE seeking nutrient neutrality or betterment in relation to new development

MWLP

- Is one element of the solution but cannot do everything
- Agricultural waste is one element of the problem Policy W3 highly unusual
 - · enable Herefordshire Council to have some control over on-farm waste management
 - requires demonstration of the approach to achieve nutrient neutrality/betterment
- Other provisions
 - requires for nutrient neutrality/betterment to be demonstrated by minerals and waste development
 - promotes development for phosphate capture and recovery
 - requires waste water treatment plant to recover phosphate for beneficial uses
 - requires energy from waste facilities to recover phosphate for beneficial uses



Other key updates

- Minerals and Waste Need Assessments
 - Both fully updated late 2019/early 2020 with data up to 2018
 - Reviewed forecasts in light of comments received
 - Extended end date to 2041
- SFRA
 - Strategic Flood Risk Assessment Level 1 for Herefordshire
 - Strategic Flood Risk Assessment Level 2 for MWLP
- Other Assessments
 - Dark Skies
 - SEA/SA
 - HRA
- GIS mapping
 - · Making digital
