Purpose

To approve the executive response to recommendations made by general scrutiny committee regarding the climate and ecological emergency review.

On 19 July 2021 the General Scrutiny Committee made a further three recommendations after reviewing the executive response to the follow up 11 recommendations that were made in response to the original 58 recommendations.

or reject a recommendation from scrutiny committee, should a recommendation not be accepted an explanation should be provided.

Key considerations

2. On 8 March 2019 the council declared a Climate Emergency following unanimous support for a climate emergency resolution at Full Council.
3. This declaration was updated on 11 December 2020 when the council declared a Climate and Ecological Emergency (CEE) following support for a climate and ecological emergency resolution at Full Council.
4. General scrutiny committee established a task and finish group on 20 January 2020 to carry out a climate emergency review.
5. The General Scrutiny committee met on 25 January 2021 to agree the report and made 58 recommendations to the executive.
6. On 25 March 2021 the executive responded to the review setting out a response to each recommendation. The full executive response is available here:

7. On 26 April 2021 General Scrutiny committee met to discuss the executive response and made an additional 11 recommendations. On 29 June 2021 the executive responded to the additional 11 recommendations The full executive response is available here:

8. On 19 July 2021 the General Scrutiny committee met to discuss the executive response to the additional 11 recommendations and made a further three recommendations.

Community impact

9. In accordance with the adopted code of corporate governance, the council is committed to promoting a positive working culture that accepts, and encourages constructive challenge, and recognises that a culture and structure for scrutiny are key elements for accountable decision making, policy development and review. Topics selected for scrutiny should have regard to what matters to residents.
10. The executive response to the report supports the council's environmental policy commitments and the County Plan's ambitions as outlined in the Environmental Impact section below.

Environmental Impact

11. The council provides and purchases a wide range of services for the people of Herefordshire. Together with partner organisations in the private, public and voluntary sectors we share a strong commitment to improving our environmental sustainability, achieving carbon neutrality and to protect and enhance Herefordshire's outstanding natural environment.
12. The objective of the Climate and Ecological Emergency task and finish group was to ensure the council's operations reflect the ambition set out in the declaration of a Climate and Ecological Emergency and the setting of the 2030 net zero carbon targets for the council and county. The executive response to the report supports the council's environmental policy commitments in aiming to:
 - Improve and extend active travel options throughout the county (EN2)
 - Understand and support sustainable living (EN3)
 - Invest in low carbon projects (EN4)
 - Identify climate change actions in all aspects of the councils operations (EN5)
 - Seek strong stewardship of the county's natural resources (EN6)
 - Protect and enhance the county's biodiversity, value nature and uphold environmental standards (EN7)
 - Develop environmentally sound infrastructure that attracts investment (EC6)
13. It strongly supports the County Plan's ambitions for Herefordshire to:
 - Protect and enhance our environment and keep Herefordshire a great place to live
 - Support an economy which builds on the county's strengths and resources

Equality duty

14. Under section 149 of the Equality Act 2010, the 'general duty' on public authorities is set out as follows:

A public authority must, in the exercise of its functions, have due regard to the need to –

- a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
- b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
- c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

15. The public sector equality duty (specific duty) requires us to consider how we can positively contribute to the advancement of equality and good relations, and demonstrate that we are paying 'due regard' in our decision making in the design of policies and in the delivery of services. As this is a decision on back office functions, we do not believe that it will have an impact on our equality duty.

Resource implications

16. There are no direct financial implications of the executive responses found in Appendix 1. There is an implication in terms of officer time within these responses however that has been taken into account when the response was provided.

Legal implications

17. Any recommendations or proposals made by General Scrutiny committee to Cabinet on a matter require, by statute, a response from Cabinet whether that be to accept, partially accept or reject a recommendation. This decision is an executive one and is a non-key decision. It is in line with the council's declaration of a Climate and Ecological Emergency in 2019 updated on 11 December 2020, and accords with the executive's response, to the Council's resolutions, in September 2019.
18. There are no legal implications arising from undertaking what is proposed.

19. There are no risks associated with agreeing the content of this report as the Executive response provides information and indicates how the work is being taken forward.
