
I refer to your application to divert Footpath LTB11 from the legal line through your garden to the field that immediately adjoins your property. At the moment this line runs inside your left-hand boundary and then into the field beyond. I have visited the site. There are no visible signs of this path in your garden and there is a large domestic oil tank about half way down that would obstruct the line of the path. At the end is a wooden fence. It is clear that walkers do not use this route, but go along the field on the line that you propose for the diversion. There is a double gate into the field, at the side of which is a new fence and a wooden cross step that acts as a stile, which is adequate. At the moment there is no finger post from the road.

The Ramblers would not object to the path being diverted from its present legal line into the field as proposed.
