Get a list of everywhere that congestion stems from in Hereford and you will find most of the time, unnecessary traffic lights are the cause. Where they can be replaced by a roundabout at a 4 way junction (Station Approach on its own is 3 examples of this), put onto sensors rather than timers, made part time or taken out completely, DO SO. For instance sometimes Edgar street heading south towards the turn in to the Old Market, the congestion can be that heavy elsewhere that you'll never move if you don't push into the yellow box when the lights change	The intention is to provide better enforcement of these restrictions through cameras.
Ross Road, Cars and lorries constantly jump the lights, yellow box should be a high priority, accidents happening on a regular basis, I use a mobility scooter and don't feel safe when trying to cross the road with cars jumping the lights	This driver behaviour cannot be addressed through camera enforcement and should be reported to the police.

Three comments if I may: 1) Yellow boxes on the Old Market/Tesco roundabout are hard to see and it is easy to find that a box further round the roundabout- not easily visible when further back - is blocked when you reach it (especially the one before the bus station exit) (2) I sometimes need to access Bewell Street to reach the All Saints Church parking space. How will the camera/system know I am legally doing this or will I have to contest a ticket every time? (3) When I visit other towns I get very anxious about all the cameras etc when I don't know the roads: it's easy to get something wrong in moving traffic. This is presumably not a desired outcome and needs to be weighed against the benefits of reducing traffic, increasing income etc. Thankyou. VIA EMAIL I read that the council will be taking over enforcement of moving traffic offences on the 01.06.22 after the consultation phase ends on 15.04.22. I have sent you a photo of a {}(Black) parked outside {}, Belmont Road. The owner of the vehicle lives at {}, Belmont Road across the road. It is the black door in the middle left of the picture. He also owns a{} (black) which he parks just to the left of {}, Belmont Road's drive. I wonder when you take over enforcement of access only orders will you be able to do anything about this abuse of the law. The police haven't done anything since I moved in apart from writing a letter to the residents across the road in January 2003 telling them they were committing an offence by parking over here. Actually they were committing an offence by entering this service road irrespective of if they then parked. Also the couple from {} park a red Ford Fiesta over here above the scooter,{}. The parents of pupils drop their children off here Monday to Friday between 07:30 to 08:30 also at the rear of the green bus shelter and also pick them up in the afternoon (Fairfield and Kingstone high schools) plus various others throughout the day. It would be great if you could solve this ongoing problem for me and my fellow residents who live in this access only road. I have given some of them copies of the police letter but they invariably ignore it. The man with the scooter was also given a copy. He ignored it from day one and the {} owners.	Thank you for your email regarding the consultation for Moving Traffic Enforcement implementation in Herefordshire which closed on the 15 th April. I have noted your comments regarding vehicles that contravene the access only restriction at Belmont Road / Belmont Avenue. At this stage, the council has consulted the public on a number of locations around the county, having initially consulted the police, road safety and public transport, in order to submit its application for the new powers to the Department for Transport. Once the council has obtained the powers an assessment of any further locations can be then considered, where mandatory consultation will need to be undertaken in the future. I note from your latest email that you are expecting the council to be able to enforce these restrictions from June, however this is not the case. The Government are enabling the regulations from June, which means that the council can apply for the powers to be transferred from the police, and this will be considered on an individual authority basis (an application) by Parliament who will need to devolve the powers. Once that process has been undertaken the council can then implement enforcement, and as noted above we have consulted on the first locations we intend to enable this.
VIA EMAIL The parish council would like its opinion on this matter to be recorded, though I am aware that the formal consultation period has ended. There is some confusion locally as to whether the consultation is about the restriction itself (weight restriction in the case of Goodrich parish), or the use of cameras for enforcement purposes. If it is the former, then the parish council is absolutely supportive of any actions that can be taken to ensure that the weight (and indeed size) limitations of the road are adhered to by drivers, and much liaison has been undertaken, and is ongoing, to this end, including the request that Highways England improve the signage from the A40. If however, the consultation refers specifically to the use of cameras for enforcement purposes, then the parish council is not supportive of this, as they consider that efforts should be concentrated on stopping the inappropriate use, rather than making money out of those who fail to take notice of the signage.	Thank you for your email, and to confirm I have included your comments within the report to be presented to Cllr Harrington in June so that the council can consider an application for obtaining these powers. In relation to your specific enquiry I can respond as follows. The intention with any enforcement is to promote compliance of existing restrictions, and the concept behind doing this with cameras is to explore areas in the county where compliance in the past (where enforced by the council or the police) has not been as effective as what we would have liked. The difficulty with any enforcement is doing it in a compliant way (using powers we have in the right way) and providing the service so that it is funded by those that break the rules through any penalty income. In the case of moving traffic contraventions such as the weight limit in Goodrich these enforcement powers were previously held by the police where an officer would need to witness a driver breaking the rules, stop the vehicle, establish who is driving, and serve them a Fixed Penalty Notice – clearly a process which requires some investment / resource. The change in the regulations announced by the UK Government will mean that councils will be able to deal with hese matters in the same way that it does with parking. In

	 practice, this means that rather than having an officer stopping a vehicle to establish the driver at the time, it is the registered keeper that becomes liable and therefore a Penalty can be issued to the address held by the DVLA via the post. And due to this change cameras would then become the most effective tool to identify contraventions, and ensure maximum compliance through enforcement which is ultimately the aim. To be clear, all Penalties will be reviewed by a trained enforcement officer prior to its issue, it will not be automated process to issue a fine, and there will be an appeals process in place as we do with parking.
VIA EMAIL At the last meeting of the Leominster Town Council Planning & Highways Committee, it was RESOLVED to support the proposals to enforce moving traffic contraventions by camera at the Green Lane/Ginhall Lane junction and stopping on school keep clear markings.
