obtained in order to assess the objectives, to understand the impact that increased enforcement could have on the highway network.

Summary of engagement or consultation undertaken (eg. who and how have you engaged with, or why do you believe this is not required)

A full public consultation has been undertaken for six weeks as required. It was published to the council's news items and social media accounts. During the consultation, 176 responses where received: a majority of 51% were in support of camera enforcement, and 43% opposed to it. Further analysis shows that the support increases among those that walk and cycle to 54%.

#### Summary of relevant findings

- 1) A large number of contraventions are currently occurring on existing restrictions.
- 2) Corrective action will improve highway traffic flow and safety.
- 3) A number of PCNs are likely be issued to members of the public as a result of enforcement.
- 4) Using experience from the parking PCN process, there are already procedures in place regarding the debt management and debt vulnerability. There is also an appeal process for drives who contest the PCN.
