Reasons for decision:	The Classroom and Mobile Removal works at Wellington Primary School in Herefordshire are planned works included in the 2021-2023 Schools Capital Maintenance Programme.
	To ensure all Council buildings are fit for purpose and maintained to the standards set out in the condition survey to address suitability, sustainability and affordability.
Highlight any associated risks/finance/legal/ equality	By not carrying out the works the school is at risk of incurring further maintenance requirements, potentially costing the Council further money.
considerations:	There is a risk that once on site, further works are identified once the demolition works start that was not previously apparent.
	A contingency has been allowed to cover unforeseen elements once the demolition works commence. Should this contingency be insufficient then a further officer decision will be required.
Details of any alternative options considered and rejected:	Do nothing. This is not recommended as the risk of these works not being completed means that the health and safety risk associated with the continued existence of the building remains.
