Consultation:	<p>Cabinet debated and approved on the 2021-2023 Local Authority School Buildings Maintenance Works, approved 17 December 2020.</p> <p>Consultation has already been done in respect of the overall programme with the Capital Strategy Consultative Group, comprising a number of Head Teachers and Council Officers, who agreed the programme as a constructive way forward for the use of the grant.</p> <p>Political groups were consulted on the programme with one comment received – The true Independents are supportive of the proposals subject to all works being closely monitored so that value for money is obtained and projects are delivered on time.</p>
Decision made:	<p>To award R F Gardiner the contract for the Classroom and Mobile Removal works at Wellington Primary School in Herefordshire, following a successful tender via Herefordshire Council’s procurement portal.</p> <p>To approve the expenditure of up to £134,020 for works, which includes a contingency of up to £12,187.66</p> <p>To approve the expenditure of up to £15,200 for professional fees.</p> <p>To approve the expenditure of up to £4,000 for surveys.</p> <p>For the project manager to manage the scheme within the Schools Capital</p>

	Maintenance Programme budget.
Reasons for decision:	<p>The Classroom and Mobile Removal works at Wellington Primary School in Herefordshire are planned works included in the 2021-2023 Schools Capital Maintenance Programme.</p> <p>To ensure all Council buildings are fit for purpose and maintained to the standards set out in the condition survey to address suitability, sustainability and affordability.</p>
Highlight any associated risks/finance/legal/equality considerations:	<p>By not carrying out the works the school is at risk of incurring further maintenance requirements, potentially costing the Council further money.</p> <p>There is a risk that once on site, further works are identified once the demolition works start that was not previously apparent.</p> <p>A contingency has been allowed to cover unforeseen elements once the demolition works commence. Should this contingency be insufficient then a further officer decision will be required.</p>
Details of any alternative options considered and rejected:	Do nothing. This is not recommended as the risk of these works not being completed means that the health and safety risk associated with the continued existence of the building remains.
