| Decision made: | That authorisation be given to implement the above recommendation in respect of the key decision dated 18 th March 2022 and spend within the approved budget to provide Various Building Fabric Improvements for Property Services Programme of Improvement Works from the 2019 Condition Reports CAP1359, of not more than £50k (inclusive of professional fees, contingencies, etc) and enter into an Agreement with S C Joseph Ltd. |
| Reasons for decision: | <p>A programme of condition surveys on key council establishments was carried out during 2019. The purpose of which was to address identified risks at an early stage to ensure that the Council’s Estate is maintained safe and fit for purpose and generally protect and enhance the value of our Corporate assets.</p> <p>The works cover improvements to numerous elements highlighted in the condition report including fencing improvement works.</p> <p>Completing the work identified through the condition surveys will enable the strategic objective of reducing reactive maintenance, and therefore revenue expenditure, through planned and targeted investment.</p> <p>S C Joseph Ltd have been identified as the bidder representing best value for money following a competitive tender and assessment process in accordance with Council procurement procedures. Quotations were sought from one contractor and one compliant tender was received for consideration.</p> <p>The work to be awarded to S C Joseph Ltd at a cost of £41,516.00.</p> <p>The PMO (Programme Management Office) will manage the delivery of the works.</p> |
