### **Purpose**

This report provides supporting information for the committee's scrutiny of Child and Adolescent Mental Health Services available to children and young people in Herefordshire.

## **Key considerations**

- 2. The Children and Young People Scrutiny Committee agreed at its previous meeting to scrutinise child and adolescent mental health services available to children and young people in Herefordshire.
- 3. To support this work, Appendix 1 of this report provides an overview of services available to all children and young people. Appendix provides a similar overview with a specific focus on looked after children.

## **Community impact**

- 7. The public sector equality duty (specific duty) requires us to consider how we can positively contribute to the advancement of equality and good relations, and demonstrate that we are paying 'due regard' in our decision making in the design of policies and in the delivery of services. Whilst this is an update on the work of the partnership and in itself has minimal equalities impacts, consideration will be made in the future where changes to services are being considered.
