Consultation:	New Cabinet Members, Cllr Powell (Children and Young People) and Cllr Bramer (Community Services and Assets) have been informed on the capital programme and the February 2023 Cabinet Report has been shared.
Decision made:	Award a contract to SC Joseph for the Fire Precaution works at Westfield School, Leominster following a successful tender on the Council's procurement portal.
	Approve the expenditure of up to £55,383.90 for the works, which includes a contingency of £5,034.90.
	Approve the expenditure of up to £6,239.63 for internal and external professional fees.
	Responsibility for monitoring the programme to be carried out by the Capital Senior Project Manager within the spend budget.
Reasons for decision:	The Fire Precaution works are included in the Schools Capital Maintenance Programme.
	SC Joseph were the successful bidder following a successful tender via the Council's procurement portal.
	To deliver beneficial improvements in the condition of the Council's Educational building stock, improving the educational experience for pupils within the buildings. To reduce ongoing building maintenance costs by addressing known defects with high maintenance cost potential and

	preventing further deterioration.
	To ensure all Council buildings are fit for purpose and maintained to the standards as set out in the condition survey to address suitability, sustainability and affordability.
