Ward:	Weobley
Consultation:	New Cabinet Members, Cllr Powell (Children and Young People) and Cllr Bramer (Community Services and Assets) have been informed on the capital programme and the February 2023 Cabinet Report has been shared.
Decision made:	Award a contract to Ice Roofing & Cladding Limited for the Roofing works at Weobley High School, Herefordshire, following a successful tender on the Council's procurement portal.
	Approve the expenditure of up to £271,416.20 for the works, which includes a contingency of up to £24,674.20.
	Approve the expenditure of up to £33,928 for internal and external professional fees.
	Responsibility for monitoring the programme to be carried out by the Capital Senior Project Manager within the spend budget.
Reasons for decision:	The Roofing works at Weobley High School are included in the Schools Capital Maintenance Programme.
	Ice Roofing & Cladding Limited were the successful bidder following a successful tender via the Council's procurement portal.
	To deliver beneficial improvements in the condition of the Council's Educational building stock, improving the educational experience for pupils within the buildings. To reduce ongoing building maintenance costs by addressing known defects with high maintenance cost potential and

	preventing further deterioration.
	To ensure all Council buildings are fit for purpose and maintained to the standards as set out in the condition survey to address suitability, sustainability and affordability.

considerations:	There is a risk that once on site, further works are identified once the Roofing works start that was not previously apparent.
	A contingency has been allowed to cover unforeseen elements once the Roofing works commence. Should this contingency be insufficient then a further officer decision will be required.
Details of any alternative options considered and rejected:	Do nothing. This is not recommended as the risk of the Roofing works not being completed means that the health and safety risk associated with the continued existence of the building remains.
•	Not to appoint. This is not recommended as Ice Roofing & Cladding Limited have been selected through a competitive tendering process.
