Decision made:	To award a contract (Works Order 4) to Tarmac Trading Ltd using the Council's NEC 4 Framework Agreement, up to the value of £1,728,572.75 to resurface C and U roads across the county.														
Reasons for decision:	<p>In order to deliver the investment set out in the decision reports above.</p> <p>The works associated with the contract are resurfacing the network on a prioritisation criteria based on condition and need.</p>														
Equality Considerations	The selection of roads for investment is considered to have a positive impact on the protected characteristics of Age and Disability. The investment set out in this report is considered to have a neutral impact on the other protected characteristics.														
Highlight any associated risks/finance/legal/equality considerations:	<p>Finance:</p> <p>Under the selection process for the framework, Officers have used the quotation information provided which shows that the total of the prices of Tarmac Trading Ltd is likely to be significantly lower than the other suppliers on the framework based upon the quotation information submitted within the framework tender and therefore this supplier gives the Council good value for money.</p> <p>A total works budget of £3.00 million has been allocated to the project, funded through Herefordshire Council's Capital Programme.
