| Reasons for decision: | These works are included in the Property Services Estates Capital Programme 2023/25. |
| | Pennys Group Limited were the successful bidder following a successful tender process. |
| | The required improvement works have been assessed and prioritised based upon select criteria which covers health and safety, operational need, impact and lifecycle and value. |
