Consultation:	New Cabinet Members, Cllr Powell (Children and Young People) and Cllr Bramer (Community Services and Assets) have been informed on the capital programme and the February 2023 Cabinet Report has been shared.
Decision made:	Award a contract to S. C. Joseph Ltd for the Special Educational Needs (SEN) Improvements and Adaptations at Sutton Primary Academy School, Hereford. Following a successful tender on the Council's procurement portal.
	Approve the expenditure of up to £160,095.71 for the SEN Improvements and Adaptations works, which includes a 10% contingency of up to £16,009.57
	Approve the expenditure of up to £8,004.78 for professional fees (5%).
	Responsibility for monitoring the programme to be carried out by the Capital Senior Project Manager within the spend budget.
Reasons for decision:	The adaptation and improvement works at Sutton Primary Academy School, Hereford will include mitigation of potential health and safety risks and will benefit all children with special educational needs or disabilities who attend the school in the future including looked after children and care leavers.

	S. C. Joseph Ltd were the successful bidder following a successful tender via the Council's procurement portal.

Highlight any associated risks/finance/legal/ equality considerations:	By not carrying out the works children at the school would have unsuitable facilities or no facilities to meet their needs and the health and safety risks for the children and staff at the school would continue or be intensified.
	There is a risk that once on site, further works are identified once the works start that was not previously apparent.
	A contingency has been allowed to cover unforeseen elements once the works commence. Should this contingency be insufficient then a further officer decision will be required.
Details of any alternative options considered and rejected:	Do nothing. This is not recommended as the risk of the adaptation and improvement works not being completed means that the council would fail in its statutory duty to place children with special educational needs and / or disabilities in schools.
	Children required to attend different schools. This is not recommended. There is a statutory process which requires the council to arrange the admission of a child with a disability or an education health and care plan to the parent / carers preferred school, unless it can be shown that to do so would prejudice other children or it would be unreasonable to do so.
	Not to appoint. This is not recommended. S. C. Joseph Ltd have been selected through a competitive tendering process.
