<b>Decision made:</b>	<p>To award a contract for highway works associated with Highway Infrastructure Investment –Tarmac Trading Ltd using the Council’s NEC 4 Framework Agreement, up to the value of £144,258.60.</p> <p>The works on the U71224 &amp; C1250 Whitchurch Road, Llangrove are in addition to those required as part of the original scheme extents identified in Works Order 17.</p>
<b>Reasons for decision:</b>	<p>In order to deliver the investment, as set out in the decision reports above.</p> <p>The works associated with the contract are resurfacing the network on a prioritisation criteria based on condition and need.</p>
<b>Equality Considerations</b>	<p>As a result of the selection of roads for investment as part of this decision is considered to have a positive impact on the protected characteristics of Age and Disability. The investment set out in this report is considered to have a neutral impact on the other protected characteristics.</p>

<p><b>Highlight any associated risks/finance/legal/equality considerations:</b></p>	<p>Finance:</p> <p>Under the selection process for the framework, Officers have used the quotation information provided which shows that the total of the prices of Tarmac Trading Ltd is likely to be significantly lower than the other Suppliers on the Framework based upon the quotation information submitted within the framework tender and therefore this Supplier gives the council good value for money.</p> <p>A total budget of £1million has been allocated to the 2025/26 project, funded through Herefordshire Councils Capital Programme. The identified works should reduce the risk to users on the network as a result of improved condition.</p> <p>Legal Implications: A procurement process to create a Highways and Public Realm Schemes Framework was conducted during January and February 2024 in accordance with the Council’s Contracts Procedure Rules.
