## **Key considerations**

2. The Health, Care, and Wellbeing Scrutiny Committee has a remit to scrutinise the Wye Valley Trust's Winter Plan in relation to how the Trust and system partners will prepare for and manage increased seasonal pressures across urgent and emergency care, primary care, and

community services. The plan focuses on ensuring patient flow, safeguarding hospital capacity, reducing ambulance handover delays, and supporting timely discharge through integrated health and social care pathways. It also incorporates learning from previous winters, aligns with national NHS England guidance, and sets out measures for workforce resilience, infection prevention, and maintaining quality of care during periods of high demand.

3. The members of the Health, Care, and Wellbeing Scrutiny Committee agreed that this item be brought to the committee on 27 October 2025 to consider this topic. Attached as Appendix 1 to this report are slides that detail the trust's winter plan for the period 2025-26.
