Decision title:	Award of highway works associated with Public Rights of Way structures (relating to PRow Works Order 5 - PRow bridges).

Decision made:	To award a contract to Velta Construction Ltd using Lot 2 of the Council's NEC 4 Framework Agreement, to the initial value of £158,390.00 to remove and replace eight existing footbridge structures on the Public Rights of Way network with new steel-beamed timber footbridges, as per locations set out in appendix 1 below. Further, this Record of Officer Decision approves a

	contingency amount of 10% of the overall award, which equates to £15,839.00.																
Reasons for decision:	To deliver the investment set out in the decision above. The works associated with the contract are to remove and replace eight existing footbridge structures on the Public Rights of Way network with new steel-beamed timber footbridges, as per locations, as set out in Appendix 1 below.																
Equality Considerations	The selection of assets for investment is considered to have a positive impact on the protected characteristics of Age and Disability. The investment set out in this report is considered to have a neutral impact on the other protected characteristics.																
Highlight any associated risks/finance/legal/equality considerations:	<p>Under the selection process for the framework, officers carried out a mini competition exercise using Lot 2 of the Council’s Highways and Public Realm Schemes Framework Agreement. Three tenders were received and an evaluation exercise based on price and quality was undertaken by officers.
